

# CARES ACT HIGHER EDUCATION EMERGENCY RELIEF FUND (HEERF) REPORTING – EMERGENCY FINANCIAL AID GRANTS TO STUDENTS

This pdf is provided in an effort to comply with the 30- and 45-day reporting requirements issued by the Secretary of the United States Department of Education on May 6, 2020.

1. Healing Mountain Massage School acknowledges that is signed and filed with the U.S. Department of Education, the recipients Funding Certification and Agreement Emergency Financial Aid Grants to students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act on April 10, 202 via grants.gov. Healing Mountain assures that the institution intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES act to provide emergency Financial aid Grants to students.
2. On April 27, 2020 Healing Mountain received from the Department of Education the total amount of funds of \$65,588 pursuant to the Certification and Agreement for Emergency Financial Aid Grants to Students.
3. As of April 30, 2020, Healing Mountain distributed \$65,588 to students under Section 18004(a)(1) of the CARES Act.
4. The total number of students at the institution eligible to participate in the in the programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a) (1) of the CARES act is 61.

- Created a list of all students and by correlating EFC
- Determining based on eligible population, a maximum award per students was established based on EFC range (0) those students received an amount of \$1500, EFC Range (40-4197) those students received \$750 and EFC Range (5421-17997) received \$408.80.
